The following individuals have submitted the required paperwork to be a candidate for a position on the FSU Executive Committee. Below is each candidate, their title, and a 150-word statement.

#### Vice President – Vote for one

Jason Rodriquez, Associate Professor. Sociology.

I have been an active member in the Faculty Staff Union since I joined UMass Boston in 2015, having served on the FSU Executive Committee representing pre-tenure faculty and on the Core Bargaining Team three times, once as Chair and currently as Co-Chair. I am proud of the work the FSU has done to improve working conditions for faculty and librarians, but there is much more work to be done. With my deep knowledge of the contract and of the issues we face as faculty and librarians on campus, I am well-positioned to do the member services that is the bread-and-butter work of the FSU. More broadly, the FSU has a responsibility to stand shoulder-to-shoulder with the other unions on campus, in solidarity, to protect the fundamental rights of workers and the core values of public higher education.

## Non-Tenure Track Faculty – Vote for two

**Keith Robert Jones**, Lecturer. Africana Studies.

Over the past 5 years, I have had the honor of serving as an NTT representative on a number of campus-wide committees, and I currently serve on the union's core bargaining team. In all union activity, my priority has been to center equity for all members and to insist upon the co-building of a campus culture that prioritizes, as Dr. King once said, "the dignity of all labor."
